The Allen Foundation

The Allen Foundation focuses its giving on programs for human nutrition in the areas of health, education, training, and research. Nonprofit, 501(c) 3 tax-exempt status is required. *Deadlines:* January/July of each year

Bank of America Charitable Foundation

Bank of America Charitable Foundation focuses its giving on economic mobility focused on needs of communities (affordable housing, small business resiliency, and neighborhood revitalization). Organizations must be based and serve communities in eligible states and local markets as deemed by Bank of America. Nonprofit, 501(c) 3 tax-exempt status is required. *Deadlines:* May/June of each year

Bridgestone Americas Trust Fund

Bridgestone Americas Trust Fund focuses its giving on Health & Social Services, STEM & Education, Environment & Conservation, and Equity & Inclusion. Organizations must deliver services in areas where Bridgestone has a physical location. Nonprofit, 501(c) 3 tax-exempt status is required.

Deadlines: Quarterly (February, May, August, November)

Brinker International Charitable Giving

Brinker International's commitment to the communities in which they live, and work extends into their giving framework to impact Kids, Hunger, and Education. Nonprofit, 501(c) 3 tax-exempt status is required.

Deadlines: 6 weeks prior to an event

Brooks and Joan Fortune Foundation

The Brooks and Joan Fortune Foundation primarily provides funds to support education, art, and outreach programs and projects. In general, the foundation desires to support specific activities that result in a defined outcome rather than general operating funds or fundraising campaigns. Nonprofit, 501(c) 3 tax-exempt status is required.

The Carls Foundation

The Carls Foundation has broadly defined charitable purposes, but the principal purpose and mission of the Foundation is based around Children's Welfare including Health care facilities and programs, with special emphasis on the prevention and treatment of hearing impairment: recreational, and educational and welfare programs especially for children who are disadvantaged for economic and/or health reasons. As well as Preservation of natural areas, open space and historic buildings and areas having special natural beauty or significance in maintaining America's heritage and historic ideals, through assistance to land trusts and land conservancies and directly related environmental educational programs. All grants have been made to non-profit organizations with 501(c)(3) tax-exempt status.

Deadlines: Ongoing

Carnegie Corporation of New York

Carnegie Corporation of New York focuses its giving on works to promote democracy, education, and peace across the globe, advancing knowledge and understanding in these areas of central importance. You do not have to be a nonprofit to submit a letter of inquiry, but funding is unlikely as the Corporation awards the majority of its grants to support public agencies, universities, and public charities that are tax exempt under section 501(c)(3) of the U.S. Internal Revenue Code or their equivalent.

Deadlines: Letters of inquiry are accepted year-round. Upon review, selected applicants will be invited to submit a full proposal.

Centene Foundation

The Foundation believes the best way to deliver healthcare is locally. The Foundation focuses on three distinct drivers of health: healthcare access, social services, and education. The Foundation recognizes that transforming the health of our communities requires more than one-time contributions, and they seek partnerships that can grow over time and position communities to thrive. Organizations require tax-exempt under Section 501(c)(3) or Section 170(b) of the Internal Revenue Code status.

Deadlines: Ongoing

Charles Lafitte Foundation

The Charles Lafitte Foundation supports innovative and effective ways of helping people help themselves and others around them to achieve healthy, satisfying, and enriched lives. To fulfill this mission the Foundation acts as grant maker, innovator, and volunteer for four main focus areas: Education, Children's Advocacy, Medical Research and Initiatives, and The Arts. Nonprofit, 501(c) 3 tax-exempt status is required.

The Chatlos Foundation

The Chatlos Foundation focuses on social concerns encompassing secular community programs which provide direct services such as child welfare, vocational training, prison alternatives, concerns for the aged and disabled, and men, women, and families in crisis. On average grants range from \$2,000 to \$5,000. Nonprofit, 501(c) 3 tax-exempt status is required. *Deadlines:* Ongoing

The Christopher D. Smithers Foundation

The focus of The Christopher D. Smithers Foundation is prevention, treatment and education about alcohol use disorder and other substance use disorders. Nonprofit, 501(c) 3 tax-exempt status is required.

Deadlines: Letters of inquiry are accepted year-round. Upon review, selected applicants will be invited to submit a full proposal.

The Cigna Group Foundation

The Cigna Group Foundation focuses their giving on socioeconomic status, education, neighborhood and physical environment, employment, and social support networks, as well as access to health care. The Foundation goes beyond financial contributions to include employee engagement, volunteer activities and community involvement. The Foundation meets these goals through partnering with nonprofit organizations and through the following grant programs: Healthier Kids for Our Future, Health and Well-Being, and Education and Workforce Development. Nonprofit, 501(c) 3 tax-exempt status is required.

Deadlines: Ongoing

Citi Foundation

Citi Foundation focuses their resources on three focus areas: Community Solutions, Financial Inclusion, and Youth Economic Opportunities. The Foundation funds organizations they believe have the capacity and expertise to successfully leverage Citi Foundation funding and have a focus on how diversity, equity, and inclusion (DEI) are prioritized within the organization and its programs. Nonprofit, 501(c) 3 tax-exempt status is required.

The Commonwealth Fund

The Commonwealth Fund carries out its mission by supporting independent research on health care issues and making grants to improve health care practice and policy. The Fund's current programs are Health Care Coverage, Access, and Tracking; Health Care Delivery System Reform; Advancing Health Equity; Controlling Health Care Costs; International Health Policy and Practice Innovations; Advancing Medicare; Medicaid; and Federal and State Health Policy. The Fund has recently launched new initiatives focused on Behavioral Health, Public Health Modernization, and Climate Change and Health Care.

Deadlines: Letters of inquiry are accepted year-round. Upon review, selected applicants will be invited to submit a full proposal.

Community Facilities Direct Loan & Grant Program in Georgia

This program provides affordable funding to develop essential community facilities in rural areas. An essential community facility is defined as a facility that provides an essential service to the local community for the orderly development of the community in a primarily rural area, and does not include private, commercial, or business undertakings. Eligible borrowers include public bodies, Community-based non-profit corporations, federally recognized Tribes Eligible areas include: Rural areas including cities, villages, townships, and towns including Federally Recognized Tribal Lands with no more than 20,000 residents according to the latest U.S. Census Data are eligible for this program.

Deadlines: Ongoing

The Dollar General Literacy Foundation

The Dollar General Literacy Foundation provides grant funding to support literacy and education initiatives serving individuals of all ages. The Foundation funds nonprofit organizations, schools, and libraries within a 15-mile radius of Dollar General stores in the states in which they operate. *Deadlines:* Varies

Dorothea Haus Ross Foundation

The mission of the Dorothea Haus Ross Foundation is to support nonprofit organizations that seek to ensure basic needs and human rights including sustenance, education, healthcare, and security to the most vulnerable children throughout the world. The Foundation's current grants programs focus on children with disabilities; those who have been trafficked or are at risk of being trafficked; and refugee or displaced children. Nonprofit, 501(c) 3 tax-exempt status is required.

Deadlines: Letters of inquiry are accepted year-round. Upon review, selected applicants will be invited to submit a full proposal.

Early Literacy Assistance Program - Literacy Empowerment Foundation

When resources permit, the Literacy Empowerment Foundation offers very cost-effective reading resources through our Early Literacy Assistance Program. These collections contain 102 softcover books. Each set contains 6 copies of 17 different titles. These 102 book sets are available for \$149.00 on a first-come, first-served basis.

Deadlines: Ongoing

Georgia-Pacific

Georgia-Pacific uses their Four E focus areas (Education, Enrichment of Community, Entrepreneurship and Environment) as guideposts for giving in ways that strengthen their communities. Due to Georgia-Pacific's desire to strengthen communities in which they work, requests must support a community served by Georgia-Pacific. GP can only fund organizations that are: nonprofit 501(c) 3 tax-exempt status, public schools, and/or other qualified state or local governmental entities.

Deadlines: Ongoing

Gilead Foundation

The Gilead Foundation welcomes funding requests for innovative, high impact projects that relate to at least one of our core therapeutic areas: HIV, Liver disease, Oncology, Inflammatory and respiratory diseases. The Foundation provides support for: Patient Community Support, Medical & Scientific Support, Corporate Sponsorships. Nonprofit, 501(c) 3 tax-exempt status is required.

Deadlines: Ongoing

Hanley Family Foundation

The Hanley Family Foundation supports charitable organizations engaged in the diagnosis and treatment of alcoholism, drug addiction and other forms of substance use disorder. The Foundation supports organizations whose primary activity is the operation of treatment programs to help individuals recover from alcoholism, drug addiction and other forms of SUD (Substance Use Disorder). Tax exempt under Section 501(c)(3) and that qualify as public charities under Section 509(a)(1), (2) or (3) of the Internal Revenue Code is required. *Deadlines:* Letters of inquiry are due January/July of each year.

Harry Chapin Foundation

The mission of the Harry Chapin Foundation is to support organizations that have demonstrated their ability to dramatically improve the lives and livelihood of people by helping them to become self-sufficient. The Foundation funds programs that operate in the United States that fall within the areas of: Arts-In-Education Programs, Community Education Programs, and Agricultural and Environmental Programs. Nonprofit, 501(c) 3 tax-exempt status is required.

Hearst Foundations

Hearst Foundations focuses its funding across four areas: Culture, Education, Health and Social Service. Within these areas, the Foundations generally provide endowment, program, and capital grant support. Nonprofit, 501(c) 3 tax-exempt status is required.

Deadlines: Ongoing

The J. Burlow Campbell Foundation

The J. Burlow Campbell Foundation focuses on using its grants for capital purposes within the areas of education, youth development, human services, public spaces, and cultural institutions. The Foundation awards grants to nonprofits in Alabama, Florida, Georgia, North Carolina, and Tennessee with priority given to programs based in Georgia. Nonprofit, 501(c) 3 tax-exempt status is required.

Deadlines: Ongoing

The Lisa Libraries

The Lisa Libraries provides books to organizations who serve in a low-income or underserved area that needs a small library, needs to rebuild or add to a library, or serves children who would benefit by being given new books to take home. A donation of books from The Lisa Libraries is free, they request that recipient organizations cover the shipping and handling costs, which is based on the destination and quantity of books. Nonprofit, 501(c) 3 tax-exempt status is required.

Deadlines: Ongoing

A Little HOPE, Inc. - The National Foundation for Grieving Children Teens and Families

A Little HOPE is a not-for-profit publicly supported charitable Foundation which grants funds to organizations that provide bereavement support services and grief counseling to children, teens, and young adults, who have experienced the death of a parent, sibling or loved one, regardless of the circumstances of the death.

Deadlines: Introductory emails are accepted year-round. Upon review, selected applicants will be invited to submit a complete application.

The Lynde and Harry Bradley Foundation

The Bradley Foundation focuses its giving on four areas: Constitutional Order, Free Markets, Civil Society, and Informed Citizens. They only fund organizations that are exempt from Federal taxation under Section 501(c) of the Internal Revenue Code and publicly supported under Section 509(a).

Deadlines: Letters of inquiry are accepted year-round. Upon review, selected applicants will be invited to submit a full proposal.

Michael and Susan Dell Foundation

The Michael and Susan Dell Foundation funds social enterprises that directly serve or impact children or youth from urban low-income communities in the areas of education, health, and family economic stability (including livelihoods and financial inclusion). These social enterprises may be structured as for-profit or nonprofit entities.

Deadlines: Ongoing

MLB-MLBPA Youth Development Foundation

The Youth Development Foundation is a joint initiative by Major League Baseball and the Players Association to support efforts that focus on improving the caliber, effectiveness and availability of amateur baseball and softball programs across the United States and internationally. The Foundation funds Capital Projects, Baseball and Softball Programs, Education Initiatives and Schools.

Deadlines: Letters of inquiry along with a budget proposal are accepted year-round. Upon review, selected applicants will be invited to submit a full proposal.

The Mott Foundation

The Mott Foundation focuses its funding through grant-making programs in Civil Society, Education, Environment, and the Flint Area. A letter of inquiry should describe the project's purpose and objectives, general methodology and total cost.

Deadlines: Letters of inquiry are accepted year-round. Upon review, selected applicants will be invited to submit a full proposal.

The Reading Resource Project - Literacy Empowerment Foundation

The Reading Resource Project is an ongoing program that runs throughout the year. The program distributes high quality, softcover books for Read Across America Day, National Drop Everything and Read Day, Children's Book Week, International Children's Book Day, and other Literacy Programs. Reading Resource Project books are 100 book sets. Any literacy-based effort qualifies for these books. You do not have to be a school or teacher. Reading Resource Project books are available in a limited quantity on a first come, first served basis. Each 100-book set will contain a variety of at least 10 different titles. Recipients merely pay shipping, handling, and administrative costs, which is only \$0.88 cents per softcover book (\$88.00 per set of 100 books).

Deadlines: Ongoing

The Reiman Foundation

The Reiman Foundation focuses its giving in four primary areas: Health Care, Education, The Arts, and Children. The application or proposal need not adhere to any specific forms. They simply ask that the information it contains be specific enough to give a clear picture of your intended project, why you are proposing it, who will benefit from it, and how it will be administered. Nonprofit, 501(c) 3 tax-exempt status is required.

Robert Wood Johnson Foundation

The Robert Wood Johnson Foundation is dedicated to building a Culture of Health that provides everyone in America a fair and just opportunity for health and wellbeing. The Foundation has four broad areas of focus: Health Systems, Healthy Communities, Healthy Children and Families, and Leadership for Better Health. Preference is given to applicants that are public entities or nonprofit organizations tax-exempt under Section 501(c)(3) of the Internal Revenue Code and not private Foundations or Type III supporting organizations. Deadlines:

- Evidence for Action: Innovative Research to Advance Racial Equity ongoing
- Pioneering Ideas: Exploring the Future to Build a Culture of Health ongoing

Walmart Local Community Grants

Walmart's local community grants are awarded through an open application process and provide funding directly from Walmart and Sam's Club facilities to local organizations in the U.S. They have 8 areas in which they focus on giving: Community and Economic Development, Diversity and Inclusion, Education, Environmental Sustainability, Health and Human Service, Hunger Relief and Healthy Eating, Public Safety, and Quality of Life. Grants are available to Nonprofits with tax-exempt status, recognized government entities, and K-12 public or nonprofit private schools.

Deadlines: Ongoing

W.K. Kellogg Foundation

W.K. Kellogg Foundation focuses its giving on three interconnected areas: Thriving Children, Working Families, and Equitable Communities. The Foundation also highlights its commitments to advancing racial equity and racial healing, to developing leaders and to authentically engaging communities with organizations they fund.

Deadlines: Letters of inquiry are accepted year-round. Upon review, selected applicants will be invited to submit a full proposal.
